

# Subscription Agreement

Updated and effective as of January 2024

## 1. Trial period

We may offer a trial subscription or an introductory price for the service. Unless the User requests cancellation at least 24 hours before the end of the trial, they will be automatically charged a price indicated on the payment screen for a chosen subscription period.

## 2. Subscription

The subscription renews automatically at the end of each period (every week, month, three months, six months, year, or otherwise, depending on the subscription plan selected by the User at the time of purchase) until the subscription is canceled.

## 3. Price

The User can purchase a subscription and/or one-time purchase directly on our Website and view the current plan prices. On our websites, we offer auto-renewable subscriptions and one-time purchases that give users regular access to content, services, and premium features. At the end of each subscription period, it will automatically renew until the User cancels it.

Please get acquainted with the prices before making an initial payment. Prices may not include bank charges payable by a user and taxes applicable in the User's country.

Please note that we reserve the right to change the subscription and/or one-time purchase prices and ask customers to check them carefully before purchasing.

## 4. Payment method

Payment will be charged to the payment method submitted by the User at the time of purchase at confirmation of purchase. The User authorizes us to charge the applicable fees to their submitted payment method.

## 5. Taxes

Subscription fees may not include applicable local taxes (such as VAT or sales tax), which, if applicable, will be communicated to the User on the payment screen before they pay for the subscription. The User hereby agrees to pay all applicable taxes.

## 6. Cancellation

The subscription renews automatically at the end of each period at the cost of the chosen

package until the User cancels it. Please note that deleting the app does not cancel subscriptions. *To avoid being charged, the User must affirmatively request subscription cancellation or cancel it in their account settings within the app at least 24 hours before the end of the trial or the then-current subscription period.*

PLEASE NOTE! The purchase of the subscription on the Website does not lead to a user being able to manage it on the App Store or Google Play.

## 7. Refunds

When the User cancels a subscription with Perky AI, only the future charges associated with their subscription are stopped. Cancellations are effective at the end of the current billing period, and as such, WNDR11 LTD (brand name – Perky AI) does not offer partial refunds for canceled subscriptions. The User will not get a refund for the current billing cycle, but they will continue to have the same access and benefits of the subscription for the remainder of the current billing period.

· If the User purchased a subscription on the Apple App Store, they may request a refund directly from Apple. Apple manages all payments made through the Apple App Store, and the User will be refunded if they are eligible for a refund according to Apple's refund policy. · If the User purchased a subscription on our Website, full subscription refunds will be granted upon request to the Perky AI billing team by emailing [support@wndr11.cy](mailto:support@wndr11.cy) within three days after payment. After three days, no refunds will be issued. Introductory prices, trials and subscriptions purchased after trials are non-refundable.

We reserve the right to issue refunds after the three days at our sole discretion. If we issue a refund, we are not obligated to issue the same or similar refund in the future.

**Note for residents of certain US states:** If you reside in California or Connecticut and cancel the purchase at any time prior to midnight of the third business day after the date of such purchase, we will return the payment you have made.

**Note for EU residents:** If you are an EU resident, you have the right to withdraw from the agreement for the purchase of digital content without charge and without giving any reason within fourteen (14) days from the date of such agreement's conclusion. The withdrawal right does not apply if the performance of the agreement has begun with your prior express consent and your acknowledgment that you thereby lose your right of withdrawal. **YOU HEREBY EXPRESSLY CONSENT TO THE IMMEDIATE PERFORMANCE OF THE AGREEMENT AND ACKNOWLEDGE THAT YOU WILL LOSE YOUR RIGHT OF**

**WITHDRAWAL FROM THE AGREEMENT ONCE OUR SERVERS VALIDATE YOUR PURCHASE AND YOU SUCCESSFULLY RECEIVE THE APPLICABLE PURCHASE.**
